# INVERSE CLUSTER MAGNIFICATION PROBLEM AND CLUSTER TOWERS 

SHUBHAM JAISWAL


#### Abstract

Inspired from the work of M Krithika and Prof. P Vanchinathan in [4], we state the Inverse Cluster Magnification Problem in this article and establish an equivalent criterion for that. We provide an important example answering a question in [4] about Cluster Towers. We also provide some generalisations and alternate proofs of results in [7] and [4].


## 1. Introduction

We will assume $K$ to be a perfect field throughout this article. Let $f$ over $K$ be an irreducible polynomial with $\operatorname{deg}(f)$ as its degree over $K$. Hence $f$ is separable. Let $\alpha$ be a root of $f$ in a fixed algebraic closure $\bar{K}$. The cluster of $\alpha$ is defined as the set of roots of $f$ in the field $K(\alpha)$. Let $r_{K}(f)$ be the cardinality of this set, that is the cluster size of $\alpha$ over $K$. Let $s_{K}(f)$ be the number of distinct fields $K\left(\alpha^{\prime}\right)$, with $\alpha^{\prime}$ varying over all the $\operatorname{deg}(f)$ roots of $f$. Let $K_{f}$ be splitting field of $f$ over $K$ inside $\bar{K}$ and $G=\operatorname{Gal}\left(K_{f} / K\right)$. Let $H \subset G$ be subgroup with $K(\alpha)$ as the fixed field that is $H=\operatorname{Gal}\left(K_{f} / K(\alpha)\right)$.

The following result is proved in [7] and [6].
Theorem 1.1. (Perlis)
(1) $r_{K}(f)$ is independent of the choice of $\alpha$ (which justifies the notation).
(2) $r_{K}(f) \cdot s_{K}(f)=\operatorname{deg}(f)$. In particular, $r_{K}(f) \mid \operatorname{deg}(f)$.
(3) $r_{K}(f)=$ number of roots fixed by $H=|\operatorname{Aut}(K(\alpha) / K)|=\left[N_{G}(H): H\right]$.

Let $L / K$ be an extension of degree $n$ contained in $\bar{K}$ and $\tilde{L}$ be its Galois closure inside $\bar{K}$. Since $K$ is perfect, by primitive element theorem, $L=K(\alpha)$ with $f$ over $K$ a degree $n$ irreducible polynomial with $\alpha$ as a root in $\bar{K}$. The cluster size of $L / K$ is defined as $r_{K}(L):=r_{K}(f)$ which is well defined by Thm 1.1(3) (Corollary 1 in [4]). Similarly one can define $s_{K}(L):=s_{K}(f)$.

Remark 1.1.1. Let $E_{1}$ and $E_{2}$ be finite extensions over $K$. Suppose one of them is Galois. Then $E_{1}$ and $E_{2}$ are linearly disjoint over $F \Longleftrightarrow E_{1} \cap E_{2}=K$ (Def 20.1 and Example 20.6 in [5]).

The following result proved in 3.1 [4] is referred to as the Cluster Magnification theorem. The theorem is reformulated in 4 [4].

Theorem 1.2. (Krithika, Vanchinathan) Let $K$, $f$ and $\alpha$ be as above. Let $\operatorname{deg}(f)=n>2$ over $K$ with cluster size $r_{K}(f)=r$. Assume that there is a Galois extension $F$ of $K$, say of degree $d$, which is linearly disjoint with $K_{f}$ over $K$. Then there exists an irreducible polynomial $g$ over $K$ of degree $n d$ with cluster size $r d$. ( $F$ can be chosen to be $K(\beta)$ for some $\beta$ in $\bar{K}$ so that $K(\alpha, \beta)=K(\alpha+\beta)$ and the irreducible polynomial of $\alpha+\beta$ over $K$, has degree nd with cluster size $r d$ ). (d is the magnification factor).

[^0]Reformulation : Let $K$ be a perfect field as above and $L / K$ be an extension of degree $n>2$ contained in $\bar{K}$ with cluster size $r_{K}(L)=r$. Let $F / K$ be any finite Galois extension of degree $d$ contained in $\bar{K}$, which is linearly disjoint with $\tilde{L}$ over $K$. Then the compositum $L F / K$ has degree $n d$ with cluster size $r_{K}(L F)=r d$. (d is the magnification factor).

In Sec. 2] we state the Inverse Cluster Magnification Problem and establish an equivalent criterion for that. In Sec. [3]we provide an important example answering a question in [4] about Cluster Towers. In Sec. 4]we provide some generalisations and alternate proofs of results in [7] and [4].

## 2. Inverse Cluster Magnification Problem

2.1. Inverse Cluster Magnification Problem for Field Extension. Let $K$ be perfect. Let $M / K$ be an extension of degree $m$ contained in $\bar{K}$ with $r_{K}(M)=k$.

Definition 2.1. $M / K$ is said to be obtained by cluster magnification from an $L / K$ if we have the following:
(1) an extension $L / K$ where $[L: K]=n>2$ and $r_{K}(L)=r$.
(2) there exists a Galois extension $F / K$ with $[F: K]=d$ such that $\tilde{L}$ and $F$ are linearly disjoint over $K$ where $\tilde{L}$ is Galois closure of $L$ in $\bar{K}$.
(3) $L F=M$.

The magnification is called trivial if $d=1$ and nontrivial otherwise. ( $d$ is the magnification factor).
Remark 2.1.1. The cluster size is preserved under isomorphism over $K$. If $M / K$ and $M^{\prime} / K$ contained in $\bar{K}$ are isomorphic over $K$, then $r_{K}(M)=r_{K}\left(M^{\prime}\right)$.

Let $\tilde{M}$ be Galois closure of $M / K$ inside $\bar{K}$. Let $G^{\prime}=\operatorname{Gal}(\tilde{M} / K)$. Let $H^{\prime} \subset G^{\prime}$ be subgroup with $M$ as the fixed field that is $H^{\prime}=\operatorname{Gal}(\tilde{M} / M)$. We have $H^{\prime}$ is normal in $G^{\prime}$ if and only if $H^{\prime}$ is trivial.

Proposition 2.2. Suppose $M / K$ is obtained by cluster magnification from an $L / K$. Let $G=\operatorname{Gal}(\tilde{L} / K)$ and $H=\operatorname{Gal}(\tilde{L} / L)$. The following hold:
(1) $s_{K}(M)=s_{K}(L)=\left[G: N_{G}(H)\right]$.
(2) $\tilde{L} F=\tilde{M}$.
(3) Let $R=\operatorname{Gal}(F / K)$. Then $G^{\prime} \cong G \times R$ where isomorphism is given by mapping $\lambda \in G^{\prime}$ to $\left(\left.\lambda\right|_{\tilde{L}},\left.\lambda\right|_{F}\right)$.
(4) Then $H^{\prime} \cong H \times\{e\} \subset G \times R$ under the above isomorphism.

Proof.
(1) From Thm 1.1 (2) and (3), $s_{K}(L)=\left[G: N_{G}(H)\right]$. Now from Thm $1.2,[M: K]=[L: K][F: K]$ and $r_{K}(M)=r_{K}(L)[F: K]$. Also from Thm 1.1 , $[M: K]=r_{K}(M) s_{K}(M)$ and $[L: K]=r_{K}(L) s_{K}(L)$. Hence $s_{K}(M)=s_{K}(L)$.
(2) Since $M=L F$, we have $\tilde{L} F \subset \tilde{M}$. Since $\tilde{L} / K$ and $F / K$ are Galois. Hence, $\tilde{L} F / K$ is Galois. Thus, $\tilde{L} F=\tilde{M}$.
(3) $\tilde{L}$ and $F$ are linearly disjoint over $K$. Since $F / K$ is Galois, $\tilde{L} \cap F=K$. Therefore, by (2) and Thm 2.1 in [1], $G^{\prime} \cong G \times R$ with the given isomorphism.
(4) Let $\lambda \in G^{\prime}$. Now,

$$
\left.\lambda \in H^{\prime} \Longleftrightarrow \lambda\right|_{M}=\left.i d_{M} \Longleftrightarrow \lambda\right|_{L}=i d_{L} \text { and }\left.\lambda\right|_{F}=\left.i d_{F} \Longleftrightarrow \lambda\right|_{\tilde{L}} \in H \subset G \text { and }\left.\lambda\right|_{F}=e \in R .
$$

We establish an equivalent criterion for inverse cluster magnification for field extension.
Theorem 2.3. $M / K$ is obtained by nontrivial cluster magnification from an $L / K$ if and only if $\operatorname{Gal}(\tilde{M} / K) \cong$ $A \times B$ for nontrivial subgroups $A$ and $B$ and $\operatorname{Gal}(\tilde{M} / M) \cong A^{\prime} \times 1$ (under the same isomorphism) for a subgroup $A^{\prime} \subset A$ with $\left[A: A^{\prime}\right]>2$.

Proof. Suppose $M / K$ is obtained by nontrivial cluster magnification from an $L / K$. From Prop 2.2(3) and (4), we get $A=G, B=R$ and $A^{\prime}=H$ with the required conditions since, $d=|R|>1, n=[G: H]>2$.

Conversely, suppose $G^{\prime} \cong A \times B$ for nontrivial subgroups $A$ and $B$ and $H^{\prime} \cong A^{\prime} \times\{e\}$ (under the same isomorphism) for a subgroup $A^{\prime} \subset A$ with $\left[A: A^{\prime}\right]>2$. We identify $G^{\prime}$ and $H^{\prime}$ with their images under the isomorphism. Now we check the three conditions of Def 2.1 for $M / K$.
(1) Since $1 \times B$ is normal in $G^{\prime}$, we have that $N:=\tilde{M}^{1 \times B}$ is Galois over $K$ with Galois group $A$. Let $L:=\tilde{M}^{A^{\prime} \times B}$. Hence $L / K$ has degree $n=\left[A: A^{\prime}\right]>2$.
(2) Since $A \times 1$ is normal in $G^{\prime}$, we have that $F:=\tilde{M}^{A \times 1}$ is Galois over $K$ with Galois group $B$ and degree $d=|B|$. Let $\tilde{L}$ be Galois closure of $L$ in $\bar{K}$. Since, $L \subset N$, we have $\tilde{L} \subset N . N \cap F$ will correspond to group generated by $A \times 1$ and $1 \times B$ which is $G^{\prime}$. Hence $N \cap F=K$. Thus $\tilde{L} \cap F=K$. So $\tilde{L}$ and $F$ are linearly disjoint over $K$.
(3) Now, $M=\tilde{M}^{A^{\prime} \times 1}$. Hence $L, F \subset M$, thus $L F \subset M$. Since $\tilde{L} \cap F=K, L \cap F=K$. Hence $[L F: K]=[L: K][F: K]=n d$. Also, $[M: K]=\left[G^{\prime}: H^{\prime}\right]=\left[A: A^{\prime}\right]|B|=n d$. Hence $L F=M$.
The magnification is nontrivial since $B$ is nontrivial subgroup.
Remark 2.3.1. In the above proof of the converse part, we can additionally conclude $N=\tilde{L}$. Since, $N \cap F=$ $\tilde{L} \cap F=K$. Hence, $[F: K]=[N F: N]=[\tilde{L} F: F]$. Now, $N F \subset \tilde{M}$ will correspond to intersection of the groups $A \times 1$ and $1 \times B$ which is trivial. Hence $N F=\tilde{M}$. From Prop [2.2 (2), $\tilde{M}=\tilde{L} F$. Hence, $[N: K]=[\tilde{L}: K]$. Thus, $N=\tilde{L}$.

Corollary 2.3.1. Let $M / K$ be Galois. Then $M / K$ is obtained by nontrivial cluster magnification from an $L / K$ if and only if $\operatorname{Gal}(M / K) \cong A \times B$ for nontrivial subgroups $A$ and $B$ with $|A|>2$. If this happens then $L / K$ is also Galois.

Proof. Since $M / K$ is Galois, $\tilde{M}=M, G^{\prime}=G a l(M / K)$ and $H^{\prime}$ is trivial. So $A^{\prime}$ is trivial and $\left[A: A^{\prime}\right]=|A|$. Also $\tilde{L}=N=L$. Hence, $L / K$ is Galois.

Proposition 2.4. Let $M^{\prime} / K$ be contained in $\bar{K}$ and $\sigma: M \rightarrow M^{\prime}$ be an isomorphism over $K$. If $M / K$ is obtained by cluster magnification from $L / K$, then $M^{\prime} / K$ is obtained by cluster magnification from $\sigma(L) / K$.

Proof. Suppose $M / K$ is obtained by cluster magnification from $L / K$. We have $L / K, n, r, F / K, d$ as above. Now we check the three conditions of $\operatorname{Def} 2.1$ for $M^{\prime} / K$.
(1) $\sigma(L) \cong L$ has degree $n>2$ over $K$ with $r_{K}(\sigma(L))=r_{K}(L)=r$.
(2) $F=\sigma(F)$ since $F / K$ is Galois. It is easy to prove that $\tilde{L}$ is Galois closure of $\sigma(L)$ in $\bar{K} . \tilde{L}$ and $F$ are linearly disjoint over $K$.
(3) $\sigma(L) F=\sigma(M)=M^{\prime}$.

Alternatively, we can use the criterion in Thm 2.3. The isomorphism between $M$ and $M^{\prime}$ extends to isomorphism between their Galois closures. Hence we also get an isomorphism between $G^{\prime}, H^{\prime}$ and corresponding groups of $M^{\prime}$.
2.2. Inverse Cluster Magnification Problem for Irreducible Polynomial. Let $g$ over $K$ be an $m$-degree irreducible polynomial over $K$ with $r_{K}(g)=k$.

Definition 2.5. We have the following equivalent definitions:
(1) $g$ over $K$ is said to be obtained by cluster magnification from an $f$ over $K$ if we have the following:
(a) an extension $K(\alpha) / K$ of degree $n>2$ with irreducible polynomial $f$ of $\alpha$ over $K$ with $r_{K}(f)=r$,
(b) there exists a Galois extension $F / K$ of degree $d$ and $K_{f}$ and $F$ are linearly disjoint over $K$, and (c) $K(\alpha) F=K(\gamma)$ where $\gamma$ is some root of $g$ in $\bar{K}$.

The magnification is called trivial if $d=1$ and nontrivial otherwise. ( $d$ is the magnification factor).
(2) $g$ over $K$ is said to be obtained by cluster magnification from an $f$ over $K$, if $M=K(\gamma)$ over $K$, for some root $\gamma$ of $g$ in $\bar{K}$, is obtained by cluster magnification from some $L / K$ with $L=K(\alpha)$, where $\alpha$ is a root of the irreducible polynomial $f$.

Remark 2.5.1. Let $s_{K}(g)=s$. Let $\gamma_{1}, \gamma_{2}, \ldots, \gamma_{s}$ be a complete set of representatives of the clusters of roots of $g$ in $\bar{K}$. Let $M_{i}=K\left(\gamma_{i}\right)$ for $1 \leq i \leq s$.
(1) All $M_{i}$ 's are isomorphic by mapping $\gamma_{i}$ 's to each other. For every $i, M_{i} / K$ is an extension of degree $m$ contained in $\bar{K}$ with $r_{K}\left(M_{i}\right)=r_{K}(g)=k$.
(2) By Prop 2.4, if for some $i, M_{i} / K$ is obtained by cluster magnification from an $L_{i} / K$ then for each $1 \leq j \leq s, M_{j} / K$ is obtained by cluster magnification from an $L_{j} / K$.
(3) Also, if $L_{i}=K\left(\alpha_{i}\right)$ for $\alpha_{i}$ a root of the irreducible polynomial $f$ then, by isomorphism of $M_{i}$ and $M_{j}$, we get $L_{j}=K\left(\alpha_{j}\right)$ where $\alpha_{j}$ is a root of $f$.

Because of the above remark, if cluster magnification holds for some root of $g$, then it holds for every root of $g$. Hence we can work with any root $\gamma$ of $g$ in $\bar{K}$. Let $M=K(\gamma)$. Let $K_{g}$ be splitting field of $g$ over $K$ inside $\bar{K}$. Let $G^{\prime}=\operatorname{Gal}\left(K_{g} / K\right)$. Let $H^{\prime} \subset G^{\prime}$ be subgroup with $K(\gamma)$ as the fixed field that is $H^{\prime}=\operatorname{Gal}\left(K_{g} / K(\gamma)\right)$.

By Thm 2.3, we get an equivalent criterion for inverse cluster magnification of irreducible polynomial.
Theorem 2.6. $g$ over $K$ is obtained by nontrivial cluster magnification from an $f$ over $K$ if and only if $\operatorname{Gal}\left(K_{g} / K\right) \cong A \times B$ for nontrivial subgroups $A$ and $B$ and (for $\gamma$ as above) $\operatorname{Gal}\left(K_{g} / K(\gamma)\right) \cong A^{\prime} \times 1$ (under the same isomorphism) for a subgroup $A^{\prime} \subset A$ with $\left[A: A^{\prime}\right]>2$ and $f$ is irreducible polynomial for a primitive element of $\left(K_{g}\right)^{A^{\prime} \times B}$ over $K$.

Definition 2.7. $g$ over $K$, not obtained by nontrivial cluster magnification, is called primitive.
Example 2.8. Some simple examples of primitive $g$ over $K$ following from Thm 1.2 and Thm 2.6
(1) If $\operatorname{deg} g=4$ or a prime $p>2$.
(2) If $\left|\operatorname{Gal}\left(K_{g} / K\right)\right|=4$.
(3) If $\operatorname{Gal}\left(K_{g} / K\right)$ is not a direct product of two nontrivial groups. In particular if $G a l\left(K_{g} / K\right)$ is simple. In particular if $\left|\operatorname{Gal}\left(K_{g} / K\right)\right|$ is a prime $p>2$.

## 3. Cluster Towers

Let $\beta_{1}, \beta_{2}, \ldots, \beta_{s}$ contained in $\bar{K}$ be a complete set of representatives of the clusters of roots of an irreducible polynomial $f$ over $K$ where $s=s_{K}(f)$. Now consider the following cluster tower of fields terminating at the splitting field with degrees of these extensions over $K$ forming the degree sequence and length of tower as number of distinct fields in the tower:

$$
K \subset K\left(\beta_{1}\right) \subset K\left(\beta_{1}, \beta_{2}\right) \subset \cdots \subset K\left(\beta_{1}, \beta_{2}, \ldots, \beta_{s}\right)
$$

A question in [4]: Is this degree sequence independent of the ordering of the $\beta_{i}$ 's?
Example 3.1. As noted in [4], if the Galois group of $f$ over $K$ is $S_{n}$ for $n>2$, we have $s=n$ and the cluster tower

$$
K \subset K\left(\beta_{1}\right) \subset K\left(\beta_{1}, \beta_{2}\right) \subset \cdots \subset K\left(\beta_{1}, \beta_{2}, \ldots, \beta_{n-1}\right)=K_{f}
$$

with degrees $n, n(n-1), n(n-1)(n-2), \ldots, n!/ 2$ and $n!$. So in this case the degree sequence is independent of ordering of $\beta_{i}$ 's. The length of the tower is $n$.

We will construct an important example which shows that in general, the degree sequence is not independent of the ordering of the $\beta_{i}$ 's.

First we mention some easy to verify properties of Euler's totient function $\phi$.
Proposition 3.2. Suppose $l \mid n$. Consider their prime factorisations $n=\prod_{p} p^{v_{p}(n)}$ and $l=\prod_{p} p^{v_{p}(l)}$ with $v_{p}(l) \leq$ $v_{p}(n)$ for every prime. ( $v_{p}$ is usual $p$-adic valuation). Then
(1) $\phi(n) / \phi(l)=(n / l) \cdot(\phi(k) / k)$ where $k=\prod_{p \nmid l} p^{v_{p}(n)}$.
(2) $k \mid(n / l)$. Hence, $\phi(l) \mid \phi(n)$.
(3) $\phi(n)=\phi(l)$ if and only if $n=l$ or $l$ is odd and $n=2 l$.
(4) $\phi(n) / \phi(l)=n / l$ if and only if for any prime $p, p|n \Longrightarrow p| l$.

Example 3.3. Let $n \geq 6$ and $\overline{\mathbb{Q}}$ be a fixed algebraic closure of $\mathbb{Q}$ and $\zeta_{n}$ be a primitive $n$-th root of unity. Let $c$ be a positive rational number and $f=x^{n}-c$ be an irreducible polynomial over $\mathbb{Q}$. (In particular, $\mathrm{c}=\mathrm{p}$ prime works for any $n$ by Eisenstein criterion). Let $c^{1 / n}$ be the positive real root of $f$. We observe, when $n$ is odd, $r=1, s=n$ and when $n$ is even, $r=2, s=n / 2$.

By Prop 1 and Thm A in [2], the Galois group of splitting field of $f$ is isomorphic to $\mathbb{Z} / n \mathbb{Z} \rtimes(\mathbb{Z} / n \mathbb{Z})^{\times} \Longleftrightarrow$ $n$ is odd or, $n$ is even with $\sqrt{c} \notin \mathbb{Q}\left(\zeta_{n}\right) \Longleftrightarrow \mathbb{Q}\left(c^{1 / n}\right) \cap \mathbb{Q}\left(\zeta_{n}\right)=\mathbb{Q}$. Assume $n$ to satisfy these conditions. Hence, order of the Galois group is $n \phi(n)$.

Yet further, assume $n$ is composite and $l \mid n$, where for the cases $n$ odd or $n \equiv 0(\bmod 4)$ we assume $2<l<n$ and for the case $n \equiv 2(\bmod 4)$ we assume $2<l<n / 2$. Let $a=c^{1 / n}$ and $b=\zeta_{n}$. Because of our assumptions, $a b^{n / l} \neq \pm a, \pm a b$ and $1<\phi(l)<\phi(n)$ by (3) of Prop 3.2, Also, $\phi(l) \mid \phi(n)$ by (2) of Prop 3.2. Since $\mathbb{Q}(b) / \mathbb{Q}$ is Galois, by Thm 2.6 in [1], we get $\operatorname{Gal}\left(\mathbb{Q}\left(a, b^{n / l}\right) / \mathbb{Q}(a)\right) \cong \operatorname{Gal}\left(\mathbb{Q}\left(b^{n / l}\right) / \mathbb{Q}\right) \cong(\mathbb{Z} / l \mathbb{Z})^{\times}$.

In particular, $c=2, n=9, l=3$ and $c=3, n=8, l=4$ work.

Because of our assumptions $(n / l)+1 \leq s$. Let the representatives of clusters of roots of $f$ be $\beta_{3}=a b^{n / l}, \beta_{(n / l)+1}=a b^{2}$ and $\beta_{i}=a b^{i-1}$ for other $1 \leq i \leq s$. Consider the following cluster towers:

$$
\mathbb{Q} \subset \mathbb{Q}\left(\beta_{1}\right) \subset \mathbb{Q}\left(\beta_{1}, \beta_{2}\right)=\mathbb{Q}_{f}
$$

with degrees $n$ and $n \phi(n)$ and length of tower $=3$.

$$
\mathbb{Q} \subset \mathbb{Q}\left(\beta_{1}\right) \subset \mathbb{Q}\left(\beta_{1}, \beta_{3}\right) \subset \mathbb{Q}\left(\beta_{1}, \beta_{3}, \beta_{2}\right)=\mathbb{Q}_{f}
$$

with degrees $n, n \phi(l)$ and $n \phi(n)$ and length of tower $=4$.
This example shows us that not only the degree sequence is not independent of the ordering of the $\beta_{i}$ 's but length of tower is also not independent of the ordering of the $\beta_{i}$ 's.

## 4. Other Interesting Results on Cluster Size

### 4.1. Existence of polynomials for given degree and cluster size over number fields.

We present the following theorem which is generalisation of a result in an unpublished note of Perlis, Exercise 4 in [6] which was for $K=\mathbb{Q}$. This theorem includes even the excluded cases in generalisation done in Thm 2 in [4] namely $n=2 r$ where $r$ is odd for $\mathbb{Q}$ and $n=2 r$ for any number field $K \neq \mathbb{Q}$.

Theorem 4.1. Let $K$ be a number field. Let $n>2$ and $r \mid n$. Then there exists an irreducible polynomial over $K$ of degree $n$ with cluster size $r$.

Before proving the theorem, we state some lemmas which we will use in the proof of the theorem.
Lemma 4.2. The group $S_{n}$ is realisable as Galois group over any number field.
Proof. (For details refer Völklein [8]). Let $K$ be a number field. Now $\mathbb{Q}$ is hilbertian. (Def 1.9 and Theorem 1.23 in [8]). Corollary 1.11 in [8] says that every finitely generated extension of a hilbertian field is hilbertian. Hence $K$ is hilbertian. We know that the group $S_{n}$ occurs regularly over every field (Def 1.14 and Example 1.17 in [8]). In particular, $S_{n}$ occurs regularly over $K$. Corollary 1.15 in [8] says that if a group occurs regularly over a hilbertian field then it is realisable as a Galois group over that field. Hence $S_{n}$ is realisable as Galois group over $K$.

The following lemma is the final proposition in [6]. We write Perlis' proof for the sake of completion.
Lemma 4.3. Let $G$ be a transitive subgroup of $S_{n}$ for some $n$. If there exists a finite Galois extension of a field $K$ with Galois group isomorphic to $G$, then there exists an irreducible polynomial $f$ over $K$ of degree $n$ and $a$ labeling of the roots of $f$ so that the Galois group of $f$, viewed as a group permuting roots of $f$, is precisely $G$.

Proof. Let $G$ act on $n$ symbols $\{1,2, \ldots, n\}$. Let $H \subset G$ be the stabiliser of the symbol 1 . Then there is a canonical labeling of the $n$ cosets in $G / H$ so that $G$ acts on $G / H$ exactly the same way $G$ acts on the original $n$ symbols that is $\left\{x_{1} H, x_{2} H, \ldots, x_{n} H\right\}$ with $x_{j} .1=j$ and $g .\left(x_{j} H\right)=x_{g . j} H$ for all $g \in G$ and all $1 \leq j \leq n$. The action is faithful and transitive. We have $\operatorname{Stab}\left(x_{j} H\right)=x_{j} H x_{j}^{-1}$. Now, $\cap_{1 \leq j \leq n}\left(\operatorname{Stab}\left(x_{j} H\right)\right)$ is trivial since action is faithful. Hence, $\cap_{1 \leq j \leq n}\left(x_{j} H x_{j}^{-1}\right)$ is trivial.

Let $N / K$ be finite Galois extension with Galois group isomorphic to $G$. We identify it with $G$. Let $L$ be the subfield of $N$ fixed by $H$. Since the Galois closure of $L / K$ in $N$ is the subfield of $N$ corresponding to the intersection of the conjugates of $H$ in $G$ and that intersection is trivial because of argument in previous paragraph. Hence $N$ is the Galois closure of $L / K$. Let $f$ over $K$ be the irreducible polynomial for a primitive element of $L / K$. We can identify the $n$ roots of $f$ with the $n$ cosets in $G / H$. This is the required $f$.

Lemma 4.4. Let $K$ be a perfect field and $K^{\prime} / K$ be a finite extension. If for a group $G$, direct products $G^{n}$ are realisable as Galois group over $K$ for each $n \in \mathbb{N}$ then they are realisable as Galois groups over $K^{\prime}$.

As a corollary we get arbitrarily finitely many non-isomorphic over $K$ Galois extensions of $K$ inside a fixed $\bar{K}$ which are pairwise linearly disjoint over $K$ with each having Galois group $G$ over $K$. Corollary also holds for $K^{\prime}$.

Proof. We will mimic the proof of Thm 4.2 in [1] which states that if every finite group can be realised as a Galois group over $\mathbb{Q}$ then every finite group can be realised as a Galois group over any finite extension of $\mathbb{Q}$.

Since $K$ is perfect and $K^{\prime} / K$ is finite, we have that $K^{\prime} / K$ is separable. Hence, $K^{\prime} / K$ has finitely many intermediate fields. Let the number of these intermediate fields (including $K^{\prime}$ and $K$ ) be $n$. Now $G^{n}$ is realisable over $K$ by assumption, say for $E / K$ Galois, we have $G a l(E / K) \cong G^{n}$. We have normal subgroups $N_{i}=G \times G \times \cdots \times 1 \times \cdots \times G$ in $G^{n}$ for $1 \leq i \leq n$ where the $i$ th coordinate is trivial and there is no restriction in other coordinates. So $N_{i} \cong G^{n-1}$. Let $E_{i}$ be the subfield of $E$ corresponding to $N_{i}$, so $E_{i} / K$ is Galois with $\operatorname{Gal}\left(E_{i} / K\right) \cong G^{n} / N_{i} \cong G$.

Now for $i \neq j, E_{i} \cap E_{j}$ corresponds to subgroup generated by $N_{i}$ and $N_{j}$ which is $G^{n}$. Hence $E_{i} \cap E_{j}=K$. Suppose for some $i \neq j$ we have $E_{i} \cap K^{\prime}=E_{j} \cap K^{\prime}$. Since $E_{i} \cap E_{j}=K$. Hence $E_{i} \cap K^{\prime}=E_{j} \cap K^{\prime}=K$. Now suppose that all $E_{i} \cap K^{\prime}$ are distinct. Since we have $n$ intermediate fields of $K^{\prime} / K, E_{i} \cap K^{\prime}=K$ for some $i$. In either case we get an $i$ such that $E_{i} \cap K^{\prime}=K$. Hence $\operatorname{Gal}\left(E_{i} K^{\prime} / K^{\prime}\right) \cong \operatorname{Gal}\left(E_{i} / K\right) \cong G$. This realises $G$ as a Galois group over $K^{\prime}$. By replacing $G$ with $G^{m}$ for any $m \in \mathbb{N}$ in the above argument, we can realise $G^{m}$ over $K^{\prime}$ for any $m$.

For the proof of the corollary, we observe that for any $n$ we have some $E / K$ Galois with Galois group $G^{n}$ and $N_{i}$ normal subgroups of $G^{n}$ and $E_{i}$ subfield of $E$ corresponding to $N_{i}$. Since $N_{i}$ are not conjugate to each other in $G^{n}$ and they pairwise generate $G^{n}$. Hence $E_{i}$ are not isomorphic to each other over $K$ and are pairwise linearly disjoint over $K$ with $G$ as Galois group of each $E_{i} / K$.

Now we prove Thm 4.1 .
Proof. For $r=1$. By Lemmas 4.2 and 4.3, there exists an irreducible polynomial $f$ over $K$ of degree $n$ with Galois group $S_{n}$. This $f$ satisfies $r_{K}(f)=1$.

For $r>1$. In solutions of Exercises 3 and 4 in [6], a solvable group $G \subset S_{n}$ is constructed with the properties that its action is transitive on $n$ points, and a point stabiliser fixes precisely $r$ points. The construction is as follows: We divide the $n$ points into $n / r=s$ packets of size $r$. Let $G$ be the group of permutations on these $n$ points generated by independent cyclic permutations on each packet, together with a cyclic permutation on the overall set of packets. Hence $G$ is transitive. This construction of $G$ has the explicit description of a semidirect product of an $s$-fold direct product of cyclic groups $C_{r}$ and a cyclic group $C_{s}$.
$G=\left(C_{r}\right)^{s} \rtimes C_{s}$ where each $C_{r}$ permutes points in a packet and action of $C_{s}$ permutes $s$ copies of $C_{r}$.

It is easy to see that any point stabiliser is isomorphic to $\left(C_{r}\right)^{s-1}$. The group $G$ is solvable since the following chain has successive cyclic quotients.

$$
1 \subset C_{r} \subset\left(C_{r}\right)^{2} \subset \cdots \subset\left(C_{r}\right)^{s} \subset G .
$$

Since direct product of solvable groups is solvable, direct products $G^{i}$ for $i \in \mathbb{N}$ are solvable. By Shafarevich's theorem, $G^{i}$ for $i \in \mathbb{N}$ are realisable as Galois groups over $\mathbb{Q}$. Hence by Lemma 4.4, $G$ is realisable as Galois group over number field $K$. By Lemma 4.3, there exists an irreducible polynomial $f$ over $K$ of degree $n$ and a labeling of the roots so that the Galois group of $f$, viewed as a group permuting roots of $f$, is precisely $G$. This $f$ satisfies $r_{K}(f)=r$.

### 4.2. Alternate proofs for results in [7] and [4].

We begin this subsection by giving an alternate proof for last equality in (3) of Thm 1.1 which is stated in [7] and proved in first Proposition in unpublished note of Perlis [6]. That is $r_{K}(f)=\left[N_{G}(H): H\right]$.

Proof. We observe that a field is isomorphic to $K(\alpha)$ over $K$ if and only if it is of the form $K\left(\alpha^{\prime}\right)$ for some root $\alpha^{\prime}$ of $f$. All these fields are contained in $K_{f}$. By Galois correspondence, $K$-isomorphic subfields of a Galois extension over $K$ correspond to conjugate subgroups of its Galois group. Hence, $s_{K}(f)=$ number of distinct $K\left(\alpha^{\prime}\right)=$ number of distinct subgroups conjugate to $H$ in $G=\left[G: N_{G}(H)\right]$. By Thm 1.1 (2) we are done.

We state the simple observation used above, as a lemma.
Lemma 4.5. Let $K$ be perfect field. For finite $L / K, s_{K}(L)$ (as defined in Sec. (1) is number of distinct fields inside $\bar{K}$ isomorphic to $L$ over $K$.

Proof. By primitive element theorem, $L=K(\alpha)$ with $\alpha$ root of some irreducible polynomial $f$ over $K$. Now, $L^{\prime}$ is isomorphic with $L$ over $K \Longleftrightarrow L^{\prime}=K\left(\alpha^{\prime}\right)$ for some root $\alpha^{\prime}$ of $f$. Thus $s_{K}(L)=s_{K}(f)=$ number of distinct $K\left(\alpha^{\prime}\right)$ for $\alpha^{\prime}$ root of $f=$ number of distinct fields isomorphic to $L$ over $K$.

Using this lemma we give an alternate proof for Cluster Magnification theorem Thm [1.2, Thm 1 in [4].
Proof. By Lemma 1, Chapter 8.15 in [3], since $F / K$ is Galois, we have

$$
\tilde{L} \cap F=K \Longleftrightarrow \tilde{L} \cap L F=L \text { and } L \cap F=K .
$$

So $[L F: K]=[L: K][F: K]=n d$. Since $F / K$ is Galois, we have
$M$ is isomorphic to $L F$ over $K \Longleftrightarrow M=L^{\prime} F$ where $L^{\prime}$ is isomorphic to $L$ over $K$.
Suppose $L_{1}$ and $L_{2}$ are isomorphic to $L$ over $K$. So their Galois closure over $K$ inside $\bar{K}$ is $\tilde{L}$. Hence, $\tilde{L} \cap L_{i} F=L_{i}$ for $i=1,2$. Thus, $L_{1} F=L_{2} F \Longleftrightarrow L_{1}=L_{2}$. By Lemma4.5, $s_{K}(L F)=s_{K}(L)$. Hence by Thm 1.1(2), $[L F: K] / r_{K}(L F)=[L: K] / r_{K}(L)$. Thus $r_{K}(L F)=r_{K}(L)[F: K]=r d$.

Remark 4.5.1. For $K$ a number field, since ${ }^{n} P_{k}$ and ${ }^{n} C_{k}$ are integers with ${ }^{n} P_{k}=k!{ }^{n} C_{k}$. By Thm4.1, we get irreducible polynomial over the field with degree ${ }^{n} P_{k}$ and cluster size $k$ !. The following theorem tells that this is true under some condition for even a general perfect field.

By using the above lemma we give an alternate proof for Thm 3 in [4].
Theorem 4.6. Let $K$ be a perfect field. Let $f$ over $K$ be irreducible of degree $n$ with Galois group $S_{n}$. For $k<n$, let $L_{k}$ be an extension of $K$ obtained by adjoining any $k$ roots of $f$ in $\bar{K}$. Let $g$ be the irreducible polynomial over $K$ for a primitive element of $L_{k}$. This polynomial has degree ${ }^{n} P_{k}$ and cluster size $k$ !.

Proof. Let $\alpha_{1}, \alpha_{2}, \ldots, \alpha_{n}$ be roots of $f$ in $\bar{K}$. Let $L_{k}=K\left(\alpha_{1}, \alpha_{2}, \ldots, \alpha_{k}\right)$. By Example 3.1 deg of $L_{k} / K$ is $n(n-1) \ldots(n-k+1)={ }^{n} P_{k}$. Since Galois group of $f$ is $S_{n}$, we have $L^{\prime}$ is isomorphic to $L_{k}$ over $K \Longleftrightarrow$ $L^{\prime}=K\left(\alpha_{i_{1}}, \alpha_{i_{2}}, \ldots, \alpha_{i_{k}}\right)$ for $k$ roots $\alpha_{i_{j}}$ of $f$. By Lemma 4.5, $s_{K}\left(L_{k}\right)$ is number of distinct fields inside $\bar{K}$ isomorphic to $L_{k}$ over $K$ which is precisely the number of ways of choosing $k$ roots from $n$ roots which is ${ }^{n} C_{k}$. By Thm 1.1(2), $r_{K}\left(L_{k}\right)=k!$.
